LANDac's Annual International Conference offers a podium for researchers, practitioners and private sector interested in all aspects of improving land governance for equitable and sustainable development; its 2018 conference takes the land-mobilities nexus as a starting point and focuses on the multiple ways in which land acquisitions feed into processes of mobility and the ways in which mobilities generate land claims.

Land-mobilities

The 2018 conference takes the land-mobilities nexus as a starting point and focuses on the multiple ways in which land acquisitions feed into processes of mobility and the ways in which mobilities generate land claims. On one side of the equation, land acquisitions trigger the inflows or outflows of people into particular areas, generate other mobilities (of capital, goods, and ideas etc.) and (re-)shape land claims. While land acquisitions may offer new livelihood possibilities and attract new groups of people, they also often lead to evictions and other forms of displacement and dispossession which affects people's access to land and land tenure security and ultimately violating people's 'right to remain'. Resettlement policies in turn may negatively affect the land rights of other groups. On the other side of the equation, migration generates new and overlapping claims in localities that offer relative security and economic possibilities. Urbanization and the rapid and uneven growth of populations in rural settings present considerable land governance challenges.

Given the variety of mobilities, what are good ways forward in land governance? Can land governance contribute to inclusive development – such as the prevention of displacement? Can it support vulnerable groups to settle in safe places and build secure and sustainable livelihoods? Can land governance prevent and address conflicts derived from mobility-related claims? How can property regimes move along with these changes and be made more responsive to challenges? How do economic transformations – value chain integration, market liberalization or reregulation – affect the ability of rural people to make a living on their lands? And what are the critical gaps in our understanding of the land-mobility nexus? For example, what do we know about the stability of communities created by investment flows – and what are the implications of land investments for the mobility or immobility of local communities? And what is the role of migrants who themselves invest in land – and who are the sometimes powerful actors in land-related negotiations with significant potential to disadvantage others?

LANDac – the Netherlands Academy on Land Governance for Equitable and Sustainable Development – brings together researchers, policy makers, development practitioners and business professionals in the field of land governance and development. With a focus on new pressures and competing claims on land and natural resources, the LANDac network conducts research, disseminates information, and organizes courses and training, while strengthening linkages between actors who might not usually meet. Our guiding question is how to optimize the link between land governance, sustainable development, and poverty alleviation.

LANDac is a partnership led by, and based at, the International Development Studies (IDS) Group of Utrecht University. Other partners include: the African Studies Centre Leiden, Agriterria, the Faculty of Geo-Information Science and Earth Observation (ITC) of the University of Twente, the Royal Tropical Institute (KIT), the Ministry of Foreign Affairs, Land Portal, Oxfam Novib, Royal Haskoning DHV, VNG International and Wageningen University and Research.
